On 11-Oct-2023 we accepted your application to reregister WELLINGTON CROQUET ASSOCIATION INCORPORATED (218744) (NZBN: 9429042840817) under the Incorporated Societies Act 2022 (2022 Act). Attached to this email is the updated Certificate of Incorporation. You should keep this certificate with your society's records.

Now that your society is reregistered, it must operate under and comply with the 2022 Act and with the constitution you provided as part of your reregistration application.

Keeping the register up to date

As a society registered under the 2022 Act you must keep certain information up to date on the register, including—

- Changes to your society's name or its constitution
- Details of its addresses including contact person details
- Officer details – when officers or their addresses change.

Documents you must file after each balance date

Each year your society must file an annual financial statement and an annual return with us (if your society is a registered charity see the note below).

Your society's balance date determines the deadlines. Within 6 months of the balance date your society must —

- complete its annual financial statements for that balance date, and
- hold its Annual General Meeting (AGM), and
- file an annual return with us, along with its annual financial statement.

We will email reminders to your society when it's time to file, so please make sure you keep your society's contact details up to date.

Note If your society is also a registered charity, you must file an annual return with Charities Services – you don't need to file an annual financial statement or an annual return with us
