Each match consists of five 13-point **handicap** games played over three rounds

Time limits will apply for each game (50 min for both Doubles and Singles) + Rule 19.13

Rule 19.13 'extension period' states that after the bell, 2 rotations are to be played in which no extra stroke can be used. If drawn after the two rotations, play to next hoop and extra strokes maybe used

Format goes doubles, followed by singles then reverse singles. Like so:

Round 1 Team A v Team B (Doubles)

Round 2 A1 v B1 ; A2 v B2 (Singles)

Round 3 A1 v B2 ; B1 v A2 (Reverse Singles)

Doubles to be played one game per lawn and singles to be double banked
